### **FINAL ORDER**

 Vidhyamandir Trust, Shree Manubhai Surajmal Jhaveri Surekhaben Campus, Opp. Shashivan, Palanpur, Banaskantha, has submitted its proposal for the Year: 2021-22 along with relevant documents. After considering the said proposal and the documents attached therewith, the committee has passed the provisional order on 18.04.2022 for the academic year: 2021-22 for Pre Primary Section, Lower Primary Section and Upper Primary Section (GSEB English Medium),

- (1) For Matushri M.R. Mehta Balmandir Rs. 21,000/- against Rs. 21,830/-,
- (2) For Smt. M.M. Mehta Balmandir Rs. 21,000/- against Rs. 21,830/- and
- (3) For Smt. M.M. Mehta Prathmik Shala (Std. 1 to 2) Rs. 21,000/- against Rs. 21,830/-, for the academic year: 2021-22.
- 2. While passing the provisional order certain terms and condition mention by the FRC one of such condition that is condition No.7 was that if the school aggrieved by the provisional fees determined by the FRC, the school has a right to file objections before the FRC within 7 days from the date of receipt of the provisional order.
- 3. On receipt of said order, the school has raised it objection while his letter dated 17.05.2022 and also School representative Mr. Mahendrabhai S. Patel (Niyamak), Mr. Shivrambhai Prajapati (Chief Account Officer) and Mr. Shailesh C. Limbachia (Manager HR) of the school Present and also additional submission submitted on dated 29.06.2022. Stating there in that the provisional fee fixed by the committee for the academic year: 2021-22 is not satisfactory.
- 4. After gone through the above submission and details of audited statement and genuine request of the school management only to improve quality standard of educations and financial strength of the teacher's committee is agreed to give some nominal hike in the fee structure for some of the standard.
- 5. Since the provisional fees determined by the FRC are acceptable to the school and the letter of acceptance is also on the record of FRC, there is no need to pass any detailed order. Accordingly determined final fees for Pre Primary, Lower Primary Section & Upper Primary Section (GSEB English Medium) as per the provisional order of FRC for the A.Y:2021-22.

6. Hence the committee has determined the final fees for the year: 2021-22.

 You are further directed that any excess fees charge from the student's over and above the mention celling shall have to be refunded to the student's.

#### Terms and conditions:

- 1 The school is not permitted to collect fees more than the final fees determined for the academic year: 2021-22.
- 2 The school is permitted to collect the fees for the academic year 2022-23 and 2023-24 by adding 5% increase in the final fees determined by the committee for the academic year 2021-22.

- 3 It is further made clear that the School is not permitted to collect fees under any head other than the head of tuition fees, term fees as permitted and admission fees of 1 month only in case of new admission and thereby causing any extra burden on the students. However, total of all these fees should not exceed the final fees determined by the committee.
- 4 It is also made clear that the School should either return the excess fees collected by the School for the year 2021-22 or give adjustment thereof, in the remaining installments of fees of 2021-22.
- 5 Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.
- 6 If the School Management has any grievance against the final fees determined by the Committee, it shall have a right to file revision application before the Fee Revision Committee along with challan of Rs.10,000/- by way of filing fees.
- 7 The School is directed to place the final order determining the final fees on its notice board as well as its website.
